**REQUISITION FOR THE PERFORMANCE OF EMERGENCY WORK OR LABOR,
OR THE FURNISHING OF EMERGENCY MATERIALS, SUPPLIES AND SERVICES**

The following requisition is hereby being filed with you for the performance of emergency work or labor, or the furnishing of emergency materials, supplies and services,

The nature of the emergency is: Rising Sun Force Main leaking sewage in the area between the entrance to the NJ Turnpike from Rt. 206 south and the Bordentown landfill fence.

The date and time of the emergency: February 12, 2013 2PM

The need for the emergency work or labor or the furnishing of emergency materials, supplies or services is as follows: Contractor to excavate and locate source of leak from pipe and apply BSA provided pipe clamp.

I hereby certify that the foregoing statements made by me concerning the nature of the emergency, the date and time of its occurrence, and the need for emergency action are true.

Rising Sun Force Main Leak – February 12, 2013

The leak was discovered during routine force main inspections. Inspections usually occur every 6 months. K. Nelson reported to T Redwood approximately 1:40pm, TR went to the site to verify the problem and location.

2:20pm TR called Ritch @ Woolston Construction and he declined the job.

2:25pm TR called RTW Construction office and was told Randy was in Cape May on a job but could do the repair on the afternoon of 2/13. TR replied we need it done as soon as possible.

2:30pm TR called Eagle Construction and spoke to Victor Dianna and after some discussion was told Victor would call back in one half hour. Fifty minutes later TR called Victor and was told by Victor they could not do the job.

After speaking with Victor from Eagle, Randy from RTW contacted the Authority and said he could arrive between 7 – 8 pm to repair the leak. RTW arrived at the WWTP at 8pm and then proceeded, with BSA personnel, to the job site.

The leak was repaired at approximately 10:15pm using a BSA supplied repair band on 6” cast iron pipe.

EMERGENCY CONTRACT AWARDED

I have been appointed to approve emergency requisitions and award emergency contracts on behalf of The Bordentown Sewerage Authority in situations involving imminent peril to life or property. I am satisfied that the emergency, as described above, exists and that either the need for the goods and services could not have been reasonably foreseen or the need for the goods and services occurred despite a good-faith effort to plan for the procurement of such goods or services. I am also satisfied that the emergency affects the public health, safety or welfare, that it involves imminent peril to life or property, and that it requires the immediate delivery of the articles or the performance of the service referred to herein. I hereby approve the requisition and authorize The Bordentown Sewerage Authority to award a contract for said work, labor, materials, supplies or services.
