# BORDENTOWN SEWERAGE AUTHORITY REGULAR MEETING MINUTES March 15, 2010

Mr. Hartman reported that Harris Auto is applying for connection to the Authority's sanitary sewer. Mr. Hartman met with the Authority Auditor to discuss FY2009 Audit. Mr. Hartman informed the Board that the Quick Mart and the Chinese restaurant on Route 206 were both major factors in grease blockages on Butts Avenue. Mr. Hartman added that he had notified the City's Code Enforcement. Mr. Hartman discussed that there could be possible cross contamination of Bossert Avenue and Thorntown Creek. We were unable to successfully TV the pipes. On March 15<sup>th</sup>, Mr. Hartman noted that the Authority received a call from DEP to inform us that a resident on Thorntown Lane reported sewage in creek on March 12<sup>th</sup>. The Authority jetted the line in question and attempted to TV the line. This attempt failed again when the submerged camera hit something.
