

BORDENTOWN SEWERAGE AUTHORITY ENGINEER'S STATUS REPORT FOR JANUARY 2014 MEETING PREPARED BY REMINGTON VERNICK & ARANGO (RV&A) ENGINEERS

PLANT TOPICS

• Energy Reduction Improvements: The project includes bar screen replacement, variable frequency drives on the oxygenation tank motors, replacement of the utility water system pumps/motors/vfd's, a new mixing system for the sludge holding tanks and addition of a secondary sludge conveyor in the sludge dewatering building. Proposed project duration is as follows:

Notice to Proceed Date: June 1, 2012 Contract Duration: 370 Calendar Days (Extended to 511 days) Contract Completion Date: Prior to June 6, 2013 (Revised to October 25, 2013)

Our firm and the BSA are finalizing a joint final punch list. All major work was accomplished within the contract period.

DEVELOPMENT TOPICS:

- Bordentown Waterfront Community: The force main piping along Route 130 is installed and satisfactorily tested. A meeting was held on Wednesday, January 15th to review design changes at the end of the force main due to the Route 130 right of way line being closer to the pavement than originally determined and the Phase II pump station location. Discussion also included how the BSA could control the pump operation if the railroad track area was flooded and the station was inaccessible.
- Team Campus: Applicant is requesting occupancy of Building F at the rear of the site. The BSA has provided an approval for a temporary certificate of occupancy with conditions.

- Route 206 Infrastructure Improvements:
 - Interchange 7 Warehouse: No activity.
 - Central Crossing Building Number 1: A submission for the new building was provided and a review letter has been provided. A draft deferred connection fee agreement has been generated by Mr. Coleman.
 - Route 206 Infrastructure:
 - ► Collapsed Sewer Main: The first sewer main section in Route 206 in front of the Best Western motel collapsed two weeks ago. Under an emergency contract the BSA replaced the 173 lineal feet of 8 inch diameter asbestos cement piping with 10 inch diameter PVC piping.
 - ▶ Route 206 Bypass Force Main: Maser Engineering who is the applicant's engineer for Central Crossing Building number 1 is designing the force main bypass system. Our office will provide Maser with updated specifications and details to utilize with their plans. A draft developer's agreement has been generated by Mr. Coleman.
 - ▶ Valero Service Station: Valero's engineer had recommenced design of a force main system solely for their station so they could add additional gas pumps and construct a mini mart. We informed the Valero Engineer of the work being performed by Maser Engineering and they will inform their client that the bypass force main may not be installed for another year. They provided the impression that their client will probably wait to expand the service station until the new bypass facilities are in place. With the bypass force main in place their temporary force main will not be necessary as Valero will be one of the few contributors to the sanitary sewer upstream of the WaWa store.
