RESOLUTION OF THE BORDENTOWN SEWERAGE AUTHORITY, IN THE COUNTY OF BURLINGTON, NEW JERSEY ENDORSING A TREATMENT WORKS APPROVAL PERMIT APPLICATION PROVIDED TO THE AUTHORITY BY VOADV PROPERTY, INC. AND FURTHER AUTHORIZING THE AUTHORITY'S EXECUTIVE DIRECTOR TO SIGN THE ENDORSEMENT PORTION OF THE TREATMENT WORKS APPROVAL PERMIT APPLICATION

WHEREAS, VOADV Property, Inc. (the "Developer") a/k/a Volunteers of America Delaware Valley, is intending to develop land identified on the official tax map of Bordentown Township as Block 140, Lot 3.02 (the "Property");

WHEREAS, a Treatment Works Approval was previously approved dependent on downstream conveyance and pump station be constructed;

WHEREAS, the downstream conveyance and pump station have not yet been constructed;
WHEREAS, the Developer is desirous of occupying the 70 residential unit senior housing building;

WHEREAS, the Developer is desirous of constructing a temporary holding tank to allow hauling of the wastewater;

WHEREAS, in order for the Developer to construct the proposed temporary sanitary sewerage holding tank, it must first obtain from the State of New Jersey, Department of Environmental Protection, Division of Water Quality certain approvals and permits;

WHEREAS, in order to obtain the approvals and permits, the Developer must also obtain the consent and endorsement of the local authority who has the responsibility for collecting and treating wastewater collected from the Property;

WHEREAS, the Developer is intending on presenting the Authority with a Treatment Works Approval Permit Application seeking said endorsement; and

WHEREAS, the Authority wishes through this resolution to memorialize its review and endorsement of the Developer's application and to further authorize the Authority's Executive Director to sign the Developer's application.

NOW, THEREFORE, BE IT RESOLVED BY THE BORDENTOWN SEWERAGE AUTHORITY, IN THE COUNTY OF BURLINGTON, NEW JERSEY, THAT:

- 1. The Treatment Works Approval Permit Application submitted to the Authority by VOADV Property, Inc. (attached hereto as Exhibit "A") is hereby approved and endorsed for submittal to the New Jersey Department of Environmental Protection.
- 2. The Authority hereby authorizes its Executive Director, Richard Eustace to sign the endorsement/consent section of the Developer's application.
