

**RESOLUTION 2019-28**

**RESOLUTION OF THE BORDENTOWN SEWERAGE AUTHORITY,  
IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY  
AUTHORIZING THE AWARD OF CONTRACT FOR ADMINISTRATIVE  
BUILDING ROOF REPLACEMENT.**

**WHEREAS**, Bordentown Sewerage Authority (the “Authority”) solicited bids for the replacement of Black’s Creek Wastewater Treatment Plant Administrative Building Roof;

**WHEREAS**, the Authority’s consulting engineer representative and the Authority’s solicitor representative were present for the bid opening which took place February 12, 2019 at 11:00am;

**WHEREAS**, Journey Contracting Company, Inc (“Journey”) submitted the apparent low bid in the amount of \$66,665.00;

**WHEREAS**, a pre-award evaluation of the Journey submitted shop drawing materials have determined that the materials and supplies to be offered by Journey are not equal to the specified materials;

**WHEREAS**, Robert Ganter Contractors submitted the next low bid in the amount of \$72,033.75, and a pre-award evaluation has determined that all specified materials will be provided as required by the Authority;

**NOW, THEREFORE, BE IT RESOLVED** by the Board Members of the Bordentown Sewerage Authority, in the County of Burlington, State of New Jersey that:

1. The Bid submitted by Journey Contracting Company is hereby rejected for the reasons previously set forth herein.
2. The award of a Contract to Robert Ganter Contractors in the amount of no more than \$72,033.75 is hereby authorized.

3. The Authority hereby certifies that immediately available funds in the amount of \$72,033.75 are available for this Contract award.
4. The Authority's Executive Director is hereby authorized to execute a Contract on behalf of the Authority with Robert Gantor Contractors for the Project, and to undertake any and all necessary action to commence construction of the Project.


