We would propose that the firm will receive a flat yearly fee of \$55,200 for all professional services rendered as General Counsel during the twelve-month term of this agreement, except for Additional Service, as defined below. The flat fee shall be paid in equal monthly installments of \$4,600.

Miscellaneous costs and expenses for travel, copies, printing, telephone, faxes, postage, computerized legal research and other miscellaneous expenses shall be billed at and paid at a flat rate of \$100.00 per month. Other costs and expenses that are advanced by check, or are otherwise paid on account of or on behalf of the Authority, shall be billed at cost.

With respect to additional services, which are defined as follows, this time would be billed separately at the rate of \$200.00 per hour:

- 1.) Services rendered on behalf of developments that are charged to the escrow accounts of developers;
- 2.) All pending or reasonably anticipated judicial or administrative litigation, hearings, appeals, arbitrations, mediations or permit appeals or modification proceedings, including all reasonable and necessary services rendered in investigation, research or preparation thereto, before any court, administrative agency, arbitration or mediation tribunal; and
- 3.) Services related to bonding, guaranteed investment contracts, the issuance of debt, or preliminary matters related thereto.
