This is a proposal for the replacement of the furnace that currently has a cracked heat exchanger located in the lab above the ceiling.

#### Work included:

- · Filling out and dropping off permits for this project.
- Opening up the drop ceiling and closing it.
- Disconnecting the existing Carrier Furnace and removing it.
- Installing one new York 80% AFUE, ECM motor, 130,000 btuh, 21 Inch width multi position fumace model TM8E130D20MP11
- Hooking up the new furnace to the existing ductwork, controls, power wiring, gas pipe and flue.
- Installing a 1" filter slot on the return for easier replacement of filter.
- Installing a new programmable thermostat Honeywell TH4210U2002.
- Starting the furnace and checking for proper operation.

A price to replace the ac at the same time. The current air conditioning system was manufactured in July of 2013, If you are not experiencing problems with this unit I don't feel you would need to replace it. It currently uses R410A refrigerant and could last another 8 to 10 years.

- Reclaiming the refrigerant and properly disposing of it.
- Disconnecting and removing the existing Carrier condensing unit and cased coil.
- Installing a new York model CM60DXA2 cased coil 5 ton with a matching York condensing unit model TCD60B41S and a S1-JTVMBD1 expansion valve.
   Adapting existing ductwork to fit new system.
- Installing a new aux drain pan and an Aquaguard to shut the system down if water should get into the aux drain pan.
- Installing condensate trap assembly with overflow safety switch.
- Connecting the new condensing unit up to the existing disconnect and controls.
- Reuse the existing refrigeration line set.
- Pressure testing and evacuating the system then properly charging it.
- Starting the system to check for proper operation.
