The pump station is currently operating with one active wet well pump with a standby Godwin portable pump as the backup.

At this month's Board meeting the Rising Sun Road Pump Station Wet Well Modifications project is anticipated to be awarded to the lowest responsible bidder. Our design and bid services proposal ends upon the generation of contracts by our firm, ensuring all parties sign the documents and distribution of the signed contract documents.

Per the contract documents once the Notice to Proceed is issued the contractor possesses ninety calendar days to complete the work. Based on this time frame, RVE prepared this construction administration proposal. During the construction period RVE proposes the following construction administration services:
