WHEREAS, The Bordentown Sewerage Authority intends to participate in the Sourcewell contract award to International Truck, Navistar, Inc, specifically, contract #060920-NVS, to purchase a 2025 HX620/A26 Roll Off Truck and Hoist; and

WHEREAS, International Truck provided a proposal to the Bordentown Sewerage Authority dated February 14, 2024; and

WHEREAS, on February 25, 2024, the Bordentown Sewerage Authority publicly advertised a notice of intent to award a contract under a National Cooperative Purchasing Agreement for Class 4-8 Chassis with Related Equipment, Accessories and Services, Sourcewell Contract #060920-NVS.

NOW, THEREFORE, BE IT RESOLVED, this 18th day of March, 2024, that contract, be and the same are hereby awarded to International Truck, in the amount of \$198,777.36 for a 2025 HX620/A26 Roll Off Truck and Hoist.




