## REQUISITION FOR THE PERFORMANCE OF EMERGENCY WORK OR LABOR, OR THE FURNISHING OF EMERGENCY MATERIALS, SUPPLIES AND SERVICES

The following requisition is hereby being filed with you for the performance of emergency work or labor, or the furnishing of emergency materials, supplies and services.

The nature of the emergency is: Armcon Pump Station, and Clifton Mill Pump Station Emergency backup Power Supply. BSA had a Generator Company look at Emergency Generators at both Pump Stations, Clifton Mill Pump Station on 8/5/24 and Armcon Pump Station on 8/7/24. In the event these stations lose Public Service power, The Emergency Generator at Cliton Mill will not automatically supply the pump station with power. At Armcon the Generator will not Automatically transfer back to Public Service Power once made available.

The date and time of the emergency: Monday August 5, 2024, and Wednesday August 7, 2024. Both issues were found by Authority staff during regular pump stations checks between 8am and 10:30am.

The need for the emergency work or labor or the furnishing of emergency materials, supplies or services is as follows: Parts and Labor to repair Emergency Generators / Transfer Switches at two Pump Stations.

I hereby certify that the foregoing statements made by me concerning the nature of the emergency, the date and time of its occurrence, and the need for emergency action are true.
