WHEREAS, The Bordentown Sewerage Authority had solicited from the following bidders the respective quotations as to price:

Customer supplied progressive cavity pumps for belt filter press feed and secondary scum pit. Purchase and installation of 6-inch globe valve for belt filter press pump.

WHEREAS, Shafts and Sleeves submitted Quote #6954 in the amount of \$17,260.00 for a contract for work on the project, and the Authority accepted that quote and awarded the contract to the vendor pursuant to Authority Resolution 2025-050 on April 28, 2025; and

WHEREAS, during the installation work under the contract, the vendor incurred unforeseen additional project costs amounting to \$5,660.00, and requested that the Authority adjust the contract amount to reflect a revised total cost of the project, in the amount of \$22,920.00; and

WHEREAS, the Authority staff and professionals recommend approval of the requested adjustment in the total contract amount for the project; and

WHEREAS, a Certificate of Availability of Funds has been provided by the designated certifying finance officer and is attached hereto.

NOW, THEREFORE, BE IT RESOLVED, this 21st day of July, 2025, that the total amount of the above-referenced contract that was awarded to the Shafts and Sleeves vendor be and is hereby revised, so that the total amount of the contract shall be \$22,920.00 for the goods or services described above.
