

RESOLUTION 2025-110

WHEREAS, The Bordentown Sewerage Authority has duly advertised according to law for bids on Contract 2025-C15, MISCELLANEOUS CHEMICALS; and

WHEREAS, bids were received, opened and announced by the Authority at its offices on August 26, 2025; and

WHEREAS, the Authority intends to award contracts to the lowest responsible bidder that met the bid requirements and specifications on each item; and

WHEREAS, a Certificate of Availability of Funds has been provided by the designated certifying officer and is attached hereto.

NOW, THEREFORE, BE IT RESOLVED this 15th day of September, 2025 that Contract 2025-C15, MISCELLANEOUS CHEMICALS, be and the same is hereby awarded as follows:

Item 1: Liquid Inorganic Sulfur Dioxide (1 ton containers), estimated maximum of 13 containers per year to Univar Solutions USA Inc. for the bid price of \$71.95 per one hundred pounds for an estimated \$18,707.00 per year, and \$37,414.00 for two years;

Item 2: Sodium Hypochlorite (1,000 gallon tank truck delivery), estimated maximum of 8,500 gallons per year to PVS Minibulk, Inc. for the bid price of \$3.25 per gallon for an estimated \$27,625.00 per year, and \$55,250 for two years;

Item 3: Dense Soda Ash (maximum 50,000 pound bulk deliveries), estimated maximum of 650,000 pounds per year to DuBois Chemicals Inc. for the bid price of \$23.40 per one hundred pounds for an estimated \$152,100.00 per year, and \$304,200.00 for two years;

Item 4: Liquid Ammonium Sulfate (1 tote per delivery), 1,800 gallons estimated per year to George S. Coyne Chemical Co., Inc for the bid price of \$7.47 per gallon for an estimated \$13,446.00 per year, and \$26,892.00 for two years.

BE IT FURTHER RESOLVED that the contracts shall be for a term of two years.

BE IT FURTHER RESOLVED that the Chairwoman and Secretary be and the same are hereby authorized and directed to execute the aforesaid contracts on behalf of the Bordentown Sewerage Authority.
